

Freedom of Information and Environmental Information Regulations caseload snapshot in December 2009



This report provides a snapshot of the Freedom of Information and Environmental Information Regulations cases that have been under consideration by the ICO for 30 days or more and are currently open. The summaries are intended to describe the nature of the information requested, they do not replicate the exact details of the requests. No decisions have been reached on these complaints. As the snapshot demonstrates, cases that take longer than 30 days tend to involve contested information of a more complex nature. Further statistics around our case handling were published in early July in our annual report (available on the website).
